These minutes are from the Town of Abita Springs Public Committee Meetings on August 3, 2021.

FINANCE COMMITTEE: Ms. Contois moved to open the Finance Committee Meeting and to accept the July 2021 minutes. Mr. Murphy seconded the motion. Jay Hawkins presented the June Financial Report. Mr. Hawkins noted that traffic ticket and fine revenue has been below budget. He added that law enforcement expenses are also down. Ms. Contois moved to close the meeting, seconded by Mr. Murphy.

GOVERNMENTAL COMMITTEE: Mr. Saussy moved to open the Governmental Committee Meeting, seconded by Mr. Murphy. Mr. Saussy moved to accept the July 2021 minutes, seconded by Mr. Murphy. Mr. Murphy moved to favorably recommend Instrument 2021-006 AN ORDINANCE TO AMEND THE ABITA SPRINGS CODE OF ORDINANCES TO REORDAIN SECTION 9-223 RELATIVE TO YARDS AND APPURTENANT STRUCTURES IN RESIDENTIAL DISTRICTS, AND (a) (3) RELATIVE TO SIDE YARD SETBACKS AND TO PROVIDE FOR RELATED MATTERS, seconded by Mr. Saussy. Mr. Saussy opened discussion relative to a zoning change from residential commercial overlay to commercial at the old Louisiana Church building and the adjacent structure at 22376 Main St. Several residents expressed opposition to a zoning change. Mr. Saussy suggested that the administration gather additional information and that the topic be revisited at a future meeting. Mr. Saussy moved to close the meeting, seconded by Mr. Patterson.

INFRASTRUCTURE COMMITTEE: Mr. Patterson moved to open the Infrastructure Committee Meeting and to accept the July 2021 minutes, seconded by Mr. Saussy. Mayor Curtis reported that the gravity sewer rehabilitation should be completed within six weeks and that the lift station rehab is approximately 40% complete. Mr. Patterson moved to close the meeting, seconded by Mr. Saussy.

ECONOMIC DEVELOPMENT COMMITTEE: Ms. Randolph moved to open the meeting and to accept the July 2021 minutes, seconded by Ms. Contois. Ms. Randolph moved to close the meeting, seconded by Ms. Contois.

Mr. Patterson made a motion to close the committee meetings, seconded by Ms. Contois.
