The following minutes were taken at the regular meeting of the Mayor and the Board of Aldermen at 6pm on May 18, 2021, at the Town Hall in Abita Springs, Louisiana. Mayor Curtis called the meeting to order.

**MAYOR'S ANNOUNCEMENTS:** Mayor Curtis introduced Keep Abita Beautiful President Sandra Slifer. Ms. Slifer reported on KAB sponsored clean-up efforts around Town. The Mayor went on to declare May as Bike Month in the Town of Abita Springs.

**PUBLIC HEARING:** Mayor Curtis opened discussion of Instrument 2021-001 AN ORDINANCE AMENDING ORDINANCE #518 OF THE TOWN OF ABITA SPRINGS ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE YEAR BEGINNING JANUARY 01, 2021, AND ENDING DECEMBER 31, 2021, ADJUSTMENT TO SECTIONS V., VI., VII., AND VIII. AND TO PROVIDE FOR RELATED MATTERS. It was explained that the budget amendment addressed necessary changes relative to grant proceeds and expenses and the DEQ Loan. Mr. Saussy moved to close the hearing seconded by Mr. Patterson.

**ROLL CALL:** Council Members Contois, Murphy, Patterson, Randolph and Saussy were present. Mr. Patterson moved to accept the April 20, 2021, meeting minutes seconded by Mr. Saussy. All were in favor. Ms. Contois made a motion to accept the March 2021 financial report, seconded by Mr. Saussy. All were in favor.

**NEW BUSINESS:** Mr. Patterson moved to introduce Instrument 2021-003 AN ORDINANCE AMENDING ORDINANCE #506 OF THE TOWN OF ABITA SPRINGS ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE YEAR BEGINNING JANUARY 01, 2020, AND ENDING DECEMBER 31, 2020, ADJUSTMENT TO SECTIONS V., XI., AND XII. AND TO PROVIDE FOR RELATED MATTERS. The motion was seconded by Mr. Murphy.
