The following minutes were taken at the regular meeting of the Mayor and the Board of Aldermen at 6pm on April 20, 2021 at the Town Hall in Abita Springs, Louisiana. Mayor Curtis called the meeting to order.

**MAYOR'S ANNOUNCEMENTS:** Mayor Curtis introduced St. Tammany Parish Corner's Office Forensic Death Investigator, Training and Community Outreach Coordinator, Chris Knoblauch and Director of Operations, Stephen Saussy to present information related to the Cribs for Kids program. It was explained that the purpose of the initiative is to keep infants safe while they sleep. Through donations, a safe sleep environment (Pack N' Play,) is provided to families in need.

**ROLL CALL:** Council Members Contois, Murphy, and Randolph were present. Alderman Patterson was absent and Alderman Saussy left after roll call. Ms. Contois moved to accept the March 16, 2021 meeting minutes seconded by Mr. Murphy. All were in favor. Ms. Contois made a motion to accept the February 2021 financial report, seconded by Ms. Randolph. All were in favor.

**OLD BUSINESS:** There was no old business to discuss.

**NEW BUSINESS:** 1.) Ms. Contois moved to introduce INSTRUMENT 2021-001 AN ORDINANCE AMENDING ORDINANCE #518 OF THE TOWN OF ABITA SPRINGS ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE YEAR BEGINNING JANUARY 01, 2021 AND ENDING DECEMBER 31, 2021, ADJUSTMENT TO SECTIONS V., VI., VII., AND VIII. AND TO PROVIDE FOR RELATED MATTERS, seconded by Mr. Murphy. 2.) Ms. Randolph moved to introduce INSTRUMENT 2021-002 AN ORDINANCE TO TERMINATE THE DEVELOPMENT AGREEMENT, EXECUTED ON JANUARY 18, 2018, BETWEEN THE TOWN OF ABITA SPRINGS AND LONESOME DEVELOPMENT LLC, seconded by Mr. Murphy. 3.) Ms. Contois moved to adopt A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ABITA SPRINGS TO DECLARE CERTAIN MOVABLE PROPERTY AS SURPLUS PROPERTY; TO PROVIDE FOR THE SALE OR OTHER DISPOSAL OF SUCH PROPERTY AND TO PROVIDE FOR RELATED MATTERS. The motion was seconded by Ms. Randolph. The vote was: Yeas: 3 Aldermen Contois, Murphy, and Randolph, Nays: 0, Absent: 2 Aldermen Patterson and Saussy. Abstain: 0.

Ms. Contois moved to adjourn the Town Council Meeting, seconded by Ms. Randolph.
