A RESOLUTION TO AUTHORIZE AN INCREASE IN GARBAGE COLLECTION RATES

WHEREAS, the Town of Abita Springs has been notified, by its waste collection service provider, Coastal Environmental Services, of increased costs for service; and,

WHEREAS, the increase is \$2.39 per cart for each customer.

THEREFORE, BE IT RESOLVED, that the Town of Abita Springs Board of Aldermen authorizes the following increase in the garbage collection rate.

CURRENT RATE:	Garbage/Recycle Service \$19.30 per cart
NEW RATE:	Garbage/Recycle Service \$21.69 per cart

BE IT FURTHER RESOLVED, that the Honorable Daniel J. Curtis, Mayor of the Town of Abita Springs is hereby granted all authority necessary to execute the increase beginning on the August 2020 billing.
