

# Town of Abita Springs

The following minutes were taken at the regular meeting of the Mayor and the Board of Aldermen at 6pm on March 16, 2021 at the Town Hall in Abita Springs, Louisiana. Mayor Curtis called the meeting to order.

**MAYOR'S ANNOUNCEMENTS:** Mayor Curtis announced recipients of the Citizen of the Year, and Volunteer of the Year Awards, George Long and Sandra Slifer respectively. Mr. Long and Ms. Slifer thanked everyone for their support.

**REPORTS:** Andre Monnot from Principal Engineering provided an update on the status of the Gravity Sewer and Lift Station Rehabilitations. Mr. Monnot noted the following projected completion dates: a.) Gravity Rehab, April 24, 2021, and b.) Lift Station, May 30, 2021. Marshal Ricky Bonnet reviewed the history of complaints most of which were related to traffic issues. Mr. Bonnet noted that Deputy Marshal Slemmer continues to handle reports of code violations. Fire District 8 Chief Brandon Stein introduced the members of the FD#8 Board of Commissioners. Mr. Stein reported that the district received 716 calls last year and averaged a 3 minute and 47 second response time.

**ROLL CALL:** Council Members Contois, Murphy, Patterson, Randolph and Saussy were present. Mr. Murphy moved to amend the agenda to consider A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ABITA SPRINGS TO DECLARE CERTAIN MOVABLE PROPERTY AS SURPLUS PROPERTY; TO PROVIDE FOR THE SALE OR OTHER DISPOSAL OF SUCH PROPERTY AND TO PROVIDE FOR RELATED MATTERS, seconded by Mr. Patterson. The vote was unanimously in favor. Mr. Murphy moved to accept the February 23, 2021 meeting minutes seconded by Mr. Saussy. All were in favor. Ms. Contois made a motion to accept the January 2021 financial report, seconded by Ms. Randolph. All were in favor.

**OLD BUSINESS:** There was no old business to discuss.

**NEW BUSINESS:** Mr. Patterson moved to add a \$5.00 minimum price to the resolution, seconded by Mr. Saussy without challenge. Mr. Saussy moved to adopt A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF ABITA SPRINGS TO DECLARE CERTAIN MOVABLE PROPERTY AS SURPLUS PROPERTY; TO PROVIDE FOR THE SALE OR OTHER DISPOSAL OF SUCH PROPERTY AND TO PROVIDE FOR RELATED MATTERS, seconded by Mr. Patterson. The vote was: Yeas: 5 Aldermen Contois, Murphy, Patterson, Randolph and Saussy, Nays: 0, Absent: 0, Abstain: 0.

Mr. Patterson moved to adjourn the Town Council Meeting, seconded by Mr. Saussy.
