**INSTRUMENT 2021-006** AN ORDINANCE TO AMEND THE ABITA SPRINGS CODE OF ORDINANCES TO REORDAIN SECTION 9-223 RELATIVE TO YARDS AND APPURTENANT STRUCTURES IN RESIDENTIAL DISTRICTS, AND (a) (3) a. RELATIVE TO SIDE YARD SETBACKS AND TO PROVIDE FOR RELATED MATTERS. IT IS HEREBY ORDAINED that the title of Section 9-223 of the Town of Abita Springs Code of Ordinances be amended and reordained to read as follows: Sec. 9-223. – Single family residential yards and appurtenant structures. BE IT FURTHER ORDAINED that Section 9-223 (a) (3) a. of the Town of Abita Springs Code of Ordinances be amended and reordained to read as follows: (a) In all districts where single family residential use is sought, the minimum dimensions of yards shall be as follows: (3) Side yard. There shall be two side yards, one on each side of the main building. a. Each side shall be a minimum of 20 feet in width, except on buildable lots measuring 75 feet or less in width, in which case the side yard on any interior lot line side of the building shall measure a minimum of 15 feet in width. BE IT FURTHER ORDAINED that in all other respects Section 9-223 shall remain unchanged and in full force and effect.
