## A RESOLUTION OF THE TOWN OF ABITA SPRINGS AUTHORIZING THE MAYOR TO ESTABLISH RULES AND REGULATIONS TO OPERATE AND MAINTAIN THE TOWN'S CEMETERIES

**WHEREAS**, the Town of Abita Springs owns and maintains Abita Springs Cemetery No.1 and Abita Springs Cemetery No 2; and,

**WHEREAS**, these cemeteries require the same attention as other types of infrastructure, community facilities, and services; and,

**WHEREAS**, the Mayor possesses the executive authority and control of Town property; and,

**WHEREAS**, it's necessary to have in place uniform rules and regulations for the operation of the cemeteries, and

**WHEREAS**, it is in the best interest of the Town of Abita Springs to establish uniform rules and regulations and to establish charges and fees in order to operate the cemeteries in a businesslike manner.

**THEREFORE, BE IT RESOLVED** that the Town of Abita Springs Board of Aldermen hereby authorizes the Mayor to establish uniform rules and regulations to effectively operate and maintain the Town cemeteries.

**BE IT FURTHER RESOLVED** that the Mayor of the Town of Abita Springs be authorized to establish administrative fees and charges to recover costs.

**AND, BE IT FURTHER RESOLVED** that the Mayor is authorized to execute any and all necessary documents in the furtherance of this resolution.

**AND, BE IT FURTHER RESOLVED**, that the Clerk of the Town of Abita Springs be authorized and directed to publish, on the Town website, the fees and regulations.
