- 1.) Appeal to the Town of Abita Springs Board of Aldermen, relative to the Historic Commission Decision regarding the Issuance of a Certificate of Appropriateness to Dorsey Development, for the Design of the Dollar General Sign.
- 2.) Introduction of Instrument 2022-004, AN ORDINANCE OF THE BOARD OF ALDERMAN TO AMEND THE ABITA SPRINGS CODE OF ORDINANCES TO REORDAIN SECTION 9-306 RELATIVE TO HISTORIC DISTRICT JURISDICTION AND TO PROVIDE FOR RELATED MATTERS.
