RESOLUTION NO. 2025-08-01

A RESOLUTION CONFIRMING THE COMMITMENT OF THE BOARD OF ALDERMEN OF THE TOWN OF ABITA SPRINGS, TO TRANSPARENCY, ACCOUNTABILITY, AND LAWFUL COORDINATION IN RESOLVING THE LEGAL, ENVIRONMENTAL, AND INFRASTRUCTURAL ISSUES SURROUNDING THE ABITA MEADOWS DEVELOPMENT

WHEREAS the Town of Abita Springs entered into a Planned Unit Development (PUD) Agreement in 2018 with Lonesome Development, LLC, regarding the Abita Meadows planned unit development; and,

WHEREAS in November 2022, a final judgment by the 22nd Judicial District Court confirmed the Development Agreement as valid and enforceable and ordered specific performance by the Town, subject to state and federal law; and,

WHEREAS the Agreement requires the Town to "provide an adequate capacity for sewerage, water, garbage, and natural gas services to the property based on maximum utilization as set forth in the PUD plan ..."; and,

WHEREAS subsequent engineering evaluations years later in 2023, have shown that the Town's existing wastewater system lacked the capacity to serve the Abita Meadows development; and,

WHEREAS the Town is currently under a compliance order from the Louisiana Department of Environmental Quality due to wastewater treatment deficiencies and associated environmental risks; and,

WHEREAS under Louisiana law, including R.S. 33:362, legislative authority is vested in the Board of Aldermen, including the responsibility to approve budgets and allocate funds for municipal obligations; and,

WHEREAS each member of the Board has taken an oath to support the Constitution and laws of the United States and the State of Louisiana, and to faithfully and impartially discharge their duties to the best of their ability.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF ABITA SPRINGS THAT:

1. Legal and Fiscal Commitment

The Board acknowledges its responsibility to comply with the Order of Specific Performance of the Development Agreement and supports allocating necessary funding, consistent with applicable laws and budgetary processes, for infrastructure improvements required to fulfill obligations related to adequate sewer, water, garbage, and gas capacity.

2. Infrastructure and Engineering Solutions

The Board supports continued work with the Mayor, engineers, and consultants to develop lawful, science-based solutions that protect public health, meet environmental standards, and fulfill the Town's obligations.

3. Pursuit of Funding Options

The Board will explore all appropriate funding mechanisms, including budget adjustments, grants, and infrastructure programs, to support required improvements with fiscal responsibility.

4. Ongoing Coordination and Transparency

The Board affirms its commitment to transparent governance and constructive coordination with the Mayor and administrative staff to ensure lawful and practical outcomes in the best interest of the Town and its residents.

BE IT FURTHER RESOLVED that a certified copy of this resolution be provided to the Mayor, legal counsel, Lonesome Development, LLC, the 22nd Judicial District Court, and the Louisiana Department of Environmental Quality.

Whereas per "Title 33 – Municipalities and Parishes R.S. 33:362 – Exercise of municipal powers; legislative, executive".

A. (1) "The legislative powers of a municipality shall be vested in and exercised by the board of alderman".

B. "The Mayor shall be the chief executive officer of the municipality";

Whereas the legislative branch per the Lawrason Act; the board must approve or disapprove the annual operating and capital improvements budgets submitted by the mayor. (The Local Government Budget Act must be followed. R.S. 39:1301);

Whereas the Board of Alderman support the funding of the Town of Abita Springs obligation in the PUD agreement between Lonesome Development, LLC and the Town of Abita Springs, [Developmental Agreement, (contract)];

Whereas a law suit lodged by Lonesome Development, LLC against the Town of Abita Springs, "Lonesome Development, LLC vs Town of Abita Springs" was adjudicated to be Final, Definitive and Un-appealable Judgement, in November of 2022;

Whereas the Final, Definitive and Un-appealable Judgement established the contract between Lonesome Development, LLC and the Town of Abita springs, [Developmental Agreement, (contract)] to be valid and enforceable;

Whereas Lonesome Development, LLC winning the law suit, has opted specific performance from the Town of Abita Springs;

Whereas the Development agreement (contract) between Lonesome Development, LLC and the Town of Abita Springs states, "Town of Abita Springs shall provide an adequate capacity for sewerage, water, garbage and natural gas services to the property based on maximum utilization as set forth in PUD plan"; and



Whereas each member of the board of Alderman took an Oath: STATE OF LOUISIANA, PARISH OF ST. TAMMANY, I, Insert "Name of individual" do solemnly swear that I will support the constitution and laws of the United
